### **A BILL**

### Student Government Handbook Enactment Act JL-2223-02

<u>Whereas:</u> JL-2122-11, "Establishing the Direction of the Associated Students of Cerritos College," ordained for the creation of a Cerritos College Student Government Handbook (res 17), subservient to the Bylaws and above the Club Guide (res 11); and

<u>Whereas:</u> In accordance with the provisions of the bill, President Mohadissa Naqvi led a Student Government Handbook Task Force, which drafted an initial working version of the handbook; and

<u>Whereas:</u> This version has now been finalized, and is ready for publication and implementation in Associated Students law; and

<u>Whereas:</u> The handbook contains important procedural details which are not explicitly expressed in other documents, such as the Constitution, the Bylaws, or easily accessible copies of past legislation; and

<u>Whereas:</u> Per Resolved #22 of JL-2122-11, some provisions of the Bylaws are nullified until the Student Government Handbook is instituted, making it imperative that the Handbook is installed as soon as possible; let it be

<u>Resolved</u>: Resolved #22 from JL-2122-11 is hereby nullified, as the Student Government Handbook has now been enacted per this bill and the provision no longer has meaning; and let it be further

**Resolved:** The Cerritos College Student Government Handbook is now officially created, passed, and enacted per the terms of JL-2122-11 Resolved #17; and let it be further

**Resolved:** The most recent copy of the Student Government Handbook, as was finalized by President of the Associated Students Mohadissa Naqvi following the adjournment of the Student Government Handbook Task Force, once assembled, shall become the current, in-effect, binding version; and let it be further

**Resolved:** Any future changes, modifications, updates, or republications of the Student Government Handbook shall be ordained only by a Joint Law between the Senate and the Cabinet
