General Course Description:

This is a beginning course in real estate which introduces the student to real estate fundamentals and principles. It is a study of the basic principles, economic aspects, and laws of real estate, including the information needed to obtain a real estate license. Topics include legal descriptions and estates; encumbrances, liens, and homesteads; agencies; contracts; mathematics; financing and lenders; appraisal; escrow; title insurance; leases, landlords, and tenants; urban economics and planning; taxation; and careers in real estate.

Competencies and Skill Requirements. At the conclusion of these courses, the student should be able to:

- 1. To solve problems related to investment, discounting notes, appraisal, commissions, interest and loans, buyer costs and seller expenses, square footage and area, proration and taxes.
- 2. Use amortization and other tables to simplify real estate mathematical computations.
- 3. Describe the types of promissory notes, then explain adjustable rate loans.
- 4. Explain a deed of trust (trust deed), a mortgage, installment sales contract, and foreclosure procedures.
- Define clauses common to financing documents: acceleration, alienation, subordination, and prepayment penalty.
- 6. Describe how private mortgage insurance has changed lending practices in California
- 7. Define the secondary money market.
- 8. Describe the services provided by title insurance companies.
- 9. List the 3 agencies that play a major role in the secondary money market.
- 10. Define escrow and list the legal requirements for a valid escrow.
- 11. Explain the differences between a CLTA standard and an ALTA extended coverage title insurance policy.
