IV.01 Student Representation Stipend Requirements, Discussion Item, 10 minutes

IV.02 Shared Governance Committee Student Representatives, Discussion Item, 10 minutes

The Senate Advisor provided an overview of campus Shared Governance Committees that still needed student representatives and offered the roles to interested Senators. Students volunteered for committees, with only 1 not being filled due to it's conflict with the Senate meeting.

IV.03 FalconSync Renewal/Replacement, Information and Discussion Item, 15 minutes

The Senate Advisor provided an overview of the FalconSync system and the upcoming review of renewing the contract with its vendor, or seeking to replace it with a competitor. Three demonstrations are scheduled for the October 11th Senate meeting: Presence, Engage (FalconSync), and CampusGroups.
