### 2. Discussion: Revisions to BP5500 & AP5520

• Dr. Raphael shared the revisions with the Title IX Ad-Hoc Committee, however there is no new update at this time.

### 3. Information & Discussion: Commencement 2020

- a. COVID-19 contingency options:
  - i. Postpone ceremony summer or fall 2020:
    - Dr. Perez provided an update from the Chancellor's Office. Chancellor's Office stated that is no likelihood that campuses can host commencement ceremonies this spring, and possibly during the fall months but it depends on public safety.
  - ii. Hold online ceremony sample option: <u>MarchingOrders</u>
    - 1. Amna Jara provided the Committee with an overview and demonstration of Marching Orders, a virtual ceremony product.
- b. The committee discussed the possibilities of having a Marching Orders virtual ceremony and holding an on campus ceremony in late Fall 2020, or combining the 2020 graduating class with the class of 2021, next spring.
  - i. Committee considered creating a survey to email to graduating students, to rank their preference of the available options.
