

First Case for Universal Design

□ Universal design is the design of products and environments to be usable by all people, to the greatest extent possible, without the need for adaptation or specialized design.



Design Idea

- Designing for people with special needs adds functionality for all of us!
- Design idea applies not just to physical spaces but to technology, as well!
- There are times when all of us are functionally blind or functionally deaf.

UD Idea Expanded

- How can the principles of physical access be applied to help people learn?
- Universal Design for Learning!
- Multiply your options!
 - Multiple means of Engagement
 - Multiple means of Representation
 - Multiple means of Expression / Action



Principles of UDL

- Provide multiple means to engage learners
 - Engagement
- Present content and information in different ways
 - Representation
- Provide multiple means for students to express what they know
 - Action/Expression



The Magic

- Designing with others in mind expands your own reality
- Individuals who are differently abled
 - interact with the world differently
 - experience the world differently
 - see the world differently
- Designing for those different from ourselves expands our perspective



Expanded Perspective

- The preschooler and the four walls
- The first grader's perception of same and different

■ TV Raman and the middle




Learning Styles

- We can have an experience of expanding our perspective by looking at how people learn!
- Different people prefer different modes for taking in information
 - Sometimes people always prefer a particular mode; sometimes is situational



Learning Profile¹


- □ Visual

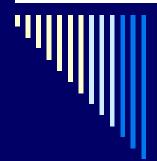



Consider Some Results

- Low on Auditory
 - May be better face-to-face than over the phone
- Low on Visual Graphic
 - May struggle with charts and graphs and maps
- □ High on Kinesthetic
 - Learn by doing



Aha!

- Auditory wife; visual graphic husband
- Auditory father; kinesthetic son
- Visual written mother; kinesthetic son



Doing Unto Others...

- □ If we are high visual written
 - May expect students to read material before the lecture/lab
- □ If we are high visual graphic
 - May assume that charts and graphs will help all students
- If we are kinesthetic
 - May expect to engage students in an activity with no written preparation



Additional Strategies?

- Lecture (auditory)
- Readings (visual written)
- Writing assignments (visual written)
- Graphic organizers (visual graphic)
- Activities (kinesthetic)




What if I'm not good at...

- As extra credit or an activity, encourage students to come up with
 - Relevant activities
 - Graphic organizers
 - Outlines
 - Videos
 - Music



UDL and Accommodations

- Legal class
 - All tests take home and open book
 - Students allowed one week
 - Writings are limited by word count—not time




Assessment

- What are you really testing?
- Are you testing students' ability to stay cool under time constraints?
- Testing their short-term memory?
- Are there "real world" parallels you could utilize?



Real World Parallels

- Legal class
 - One-week because lawyers work under some time limits
 - Open book because lawyers always have references
 - Word limit because that is what is expected in that profession
- And, this instructor is never asked for accommodations on tests!



Simple Ideas that You Can Use!

WHAT CAN YOU DO?



For Non-auditory Learners

- Speak looking directly at the person
 - Allows additional visual context
- Build in pauses
 - Allows processing time
- Point; use gestures; draw
 - Uses visual to reinforce auditory
- Include captions
 - Seeing and hearing aids in learning new vocabulary



For Non-visual Learners

- Use concrete terms
 - Avoid this, that, here, there, thing
- Meaningless!
 - "Get that thing over there."
 - "You can see that...."
 - "Set both factors equal to zero and solve."
- Provide e-text so that students can use text-to-speech (TTS) to hear materials read aloud



For Kinesthetic Learners

- "Walk" them through the steps
- Make sure they know where to go and what to do when they get there
- Draw on maps when giving directions
- Include "activity-based" homework and assessment when possible



Multiple Modalities

Design so that materials can be used in whichever modality works best for the learner!




Captions

- One of the BEST examples of universal design and access
- Seeing and hearing new vocabulary aids learning
 - Many studies have shown that captions aid anyone learning new vocabulary
- Transcripts can be translated and searched in multiple languages



Audio Description

- Describing actions in words
- Clearly verbalizing processes
 - Reinforces vocabulary
 - Makes steps concrete
 - Provides clarity of purpose of steps
- Teaches to all modalities




E-text

- By creating text documents, all students can…
 - Translate the text using Google translate
 - Easily highlight text, make notes, copy quotes




AND

□ E-text is the basis for allowing assistive technology to interact with documents!



Technology for UDL


- Programs (Assistive Technology or AT) which some individuals with disabilities MUST have for access can aid many learners
- AT enhances interactivity of learning materials



E-text Creates Flexibility


Can use software to have the text read aloud

- Can use software to create MP3s
 - Listen on the go
- Balabolka creates MP3s for free!




Listen to Learn

- Text-to-speech (TTS) programs read aloud
 - Benefits those who are highly auditory or who have visual impairments
- Many also have "multimodal" features (visually highlights as it reads)
 - Benefits those who are auditory and visual or who have learning disabilities
 - Also benefits those with attention difficulties






Free TTS Options

 - Adobe Reader




High Visual

- Graphic organizer programs allow "mind-mapping" (visual graphic)
- Toggle from graphic to written (visual written) or vice versa!

 - Built-in feature




Low Auditory & High Visual

- Sonocent Audio Notetaker
 - "Visual" interface of what you are hearing



Low Auditory High Kinesthetic

- Learn to write in cursive!
 - Uses large muscles; can help to take notes when listening
- Sonocent may also help
 - Use the color-coding and organizing features to engage in "doing" while listening




Low Visual Written

- Speech recognition programs allow you to write using your voice
 - Benefits those who are highly auditory or who have learning disabilities or who cannot use the keyboard/mouse



AT Examples

- Dragon NaturallySpeaking
 - PC
- Dragon Dictate
 - Mac
- Built-in options on Mac & PC
 - Mac: Mac Dictation
 - PC: Windows Speech Recognition

- Add up to teaching all students in ways that better meet individual needs!


