GETTING STARTED USING GI BILL BENEFITS AT CERRITOS COLLEGE AS A NEW STUDENT

Apply to Cerritos College: www.opencccapply.net/gateway/apply?cccMisCode=811

Meet with an academic counselor for your educational plan (Ed Plan).

- All courses must be on your Ed Plan in order to be certified under your GI Bill benefits.
- Schedule an appointment with an academic counselor: www.cerritos.edu/va/contact-your-va-counselor.htm

Provide official college transcripts directly to Admissions and Records: admissions-info@cerritos.edu

- Students will need a copy of transcripts before scheduling a counselor meeting. Unofficial transcripts are
 acceptable for counseling meetings, but all students are required to turn in official transcripts from all other
 schools attended to Cerritos College.
- If you have not attended any other colleges, you will need a copy of your high school transcripts.

Provide a copy of your Certificate of Eligibility (COE) from the VA

- This is for GI Bill Chapters 30, 33, 35, & 1606 only.
- Chapter 31 students do not need to provide a COE.

Vocational Rehabilitation Program

- Provide PO authorization number from your vocational rehabilitation (Voc Rehab) counselor
- Email your PO number, with Cerritos College as the authorized school, to the school certifying official (SCO), Theresa Torres (ttorres@cerritos.edu).

Provide a copy of your Member-4 DD214 (prior service members only)

- Ensures your eligibility for priority registration as a student veteran.
- This also gives you transferable military credit on your transcripts.
- For veterans that are still Active-Duty, without a DD214, provide us with a copy of your CAC ID and Student Number to place you in the Veteran Priority Group for enrollment purposes.

Request to be certified using your GI Bill Benefits: www.cerritos.edu/va/contact.htm.

- Be sure to have completed previous steps listed before requesting to be certified.
- Students can request certification only after officially enrolled in courses listed on the student's Ed Plan.

- Each service member must go through their own command's administration or Educational Services Officer (ESO) to determine eligibility prior to enrolling at Cerritos College.
