Amy Parker- This case is to challenge the current Bylaws that are in contradiction with the Brown Act which is a state law about open meetings. This is necessary to avoid future conflicts with the Brown Act which could cause legal issues for ASCC. In terms of whether the Court should hear this case, it does have original jurisdiction, and there right to a trial in the Court with original jurisdiction. I would also ask that should you decide to take this case a civil action number will be provided just for organizing all the documents that the Court clerk will receive during this case. Given this case was listed on the agenda as an informational item, not an action item, that technically the decision would be up to the Chief Justice on whether to take on the case or not. But if that's the method you choose to resolve this, in that case, you would be subject to a Robert Rules of Order motion to appeal the judgment of the chair, If the other justices do not agree with the decision of the chair on whether to take the case.
