MEMORANDUM OF UNDERSTANDING BETWEEN THE CERRITOS COMMUNITY COLLEGE DISTRICT AND THE CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS CERRITOS CHAPTER 161

August 4, 2022

The Memorandum of Understanding is hereby entered into between the Cerritos Community College District and the California School Employees Association and its Cerritos Chapter 161, pursuant to the Educational Employment Relations Act and the Collective Bargaining Agreement between the parties.

REMOTE WORK & TELECOMMUTING

Notwithstanding and in addition to the provisions of the Collective Bargaining Agreement, the parties agree that the development of a District policy and procedure for the facilitation of remote working arrangement (also known as telecommuting) is in the best interest of the District, its staff, and students. In pursuit of those ideals, the parties agree as follows:

- 1. Following execution of this Agreement, and during the Fall semester of 2022, the District Superintendent-President or designee will empanel a Task Force for the purposes of developing a remote work/telecommute policy and procedures, with the express intent of developing a comprehensive plan that meets the needs of the District and its students.
- The Task Force shall include no less than three (3) representatives from CSEA for purposes of 2. directly informing the recommended parameters of the remote work/telecommute policy.
- A Task Force recommendation is expected to be completed as soon as reasonably possible, and 3. will be referred to the Coordinating Committee for final review before a recommendation is advanced to the Board of Trustees.
- Once a final recommendation to the Board has been approved, the parties mutually agree to meet 4. and negotiate the impacts and effects of implementing the remote work/telecommuting policy.

It is expressly understood that this is a one-time agreement, and this memorandum of understanding shall not be considered precedent setting, nor will it establish a status quo, but instead shall sunset and have no force or effect once a policy recommendation has been advanced to the Coordinating Committee by the Task Force.
