Accounting students are encouraged to volunteer at the Cerritos College VITA Day. To volunteer you will need to complete the following prior to March 23, 2024:

- 1. Pass the "Standards of Conduct" test
- 2. Pass the "Intake Interview" test
- 3. Pass the "Basic" or "Advanced" tax preparation test
- 4. Sign Form 13615 and bring it with you to the VITA event

## **Tax Appointment Reminders**

## REMINDER \*What to Bring\*:

- For married filing joint, both spouses MUST be present
- Government issued valid photo identification for you and your spouse (if married)
- Original Social Security Cards or Individual Taxpayer Identification Number (ITIN) / cards for yourself, your spouse, and dependents.
- Birth dates for you, spouse, and/or dependents
- A copy of last year's tax return (optional)
- All forms W-2 and 1099, Information for other income
- Health Insurance Statements: Forms 1095-A, B or C (ACA Statements)
- Information for all deductions and credits (including charitable contributions)
- Total paid to daycare provider and their tax ID number
- For direct deposit of refund, proof of account, account number, and bank's routing number
- For prior year returns, copies of income transcripts from IRS (and state, if applicable)
  - -Customers should arrive 10-15 minutes prior to their appointment
    - -Any Appointment that arrives 15 or more minutes late MAY HAVE TO RESCHEDULE

Please note: The event does not offer services pertaining to business income with a loss (Schedule C) or capital gains (Schedule D)
