A BILL

Funding Request for the Music Department SB-2223-02

Whereas:

The music program serves music majors and non-majors which provides a sense of community at Cerritos while also enhancing the campus life experience through various activities and performances that students can participate in, and community members attend.

Whereas:

The music program requests funding for the following resources: Sheet music which gives students access to a diverse library to play from that can enhance development of cultural awareness. Clinicians and Adjudicators allow students to meet with industry leaders which create networking opportunities and help build career experience.

Whereas:

Field Trips allow students to undertake cultural outreach activities and gives students impactful experiences outside of Cerritos. Equipment and Uniforms helps students bridge economic barriers for participation, thus increasing student equity. Repair and Maintenance to increase the longevity of musical equipment and resources acquired.

Whereas:

David Betancourt makes this request on behalf of the music department to address a short fall of funds missing in the department. This is due to a clerical error that resulted in the Music Department not filing for request of yearly funds. This funding request is to fill that one-time deficit.

Whereas: Siting inflation as a real potential for rising costs, a marginal adjustment to the funding

request is offered. Given the potential of unforeseen circumstances with sheet music, equipment, and repairs an adjustment is offered. Given the strong potential for career engagement from clinicians and adjudicators, an adjustment is offered. Given the potential for fundraising for field trips in particular, no adjustment is offered.

Resolved: The ASCC Senate shall approve SB-2223-02 to transfer \$15,000 from the ASCC Senate

Fund account #600-03-015, to Music Department account #600-02-001 for detailed

resource allocation.

Resolved: Any remaining funds not used by the Music department as approved will be returned to

the aforementioned ASCC account #600-03-015 at the end of the 2022-2023 fiscal year.
