### **III.02 Associate Justice Inauguration, Action Item**

Senator Montes de Oca moves to approve Joseph Kwon as an Associate Justice. Seconded by Senator Tsui. No objections, motion passes. Justice Kwon was sworn in by Vice President Avila.

### **III.04 Reduction to 20-21 ASCC Budget: Request Revised Funding Requests, Action Item**

The ASCC Senate will take action SB-2021-01, to request revised funding requests from budget sections 2,4 and 5, due to expanded reduced revenue resulting from COVID-19.

Senator Gutierrez moves to amend SB-2021-01 by striking from the last Resolved “, which reflect requested events, activities, and services occurring in a remote/online environment” and insert “. Requestor shall be able to adjust their request based on current circumstances but may not exceed reduced limits for their club/department”. Seconded by Senator Villalobos. No objections, motion passes.

Senator Hernandez moves to approve SB-2021-01 with amendments. Seconded by Senator Rodriguez. No objections, motion passes.

### **III.05 Election of Faculty Senate Liaison, Action Item**

ASCC Faculty Senate Liaison must be available Tuesdays from 11am-12pm. Senator Rodriguez moves to postpone item III.05 to next week so the new Senators can learn more about the position. Seconded by Senator Hernandez. No objections, motion passes.
