#### Additional Funding for Phi Beta Lambda (PBL) / Future Business Leaders of America (FBLA) National Conference Participation

SB-2425-14

- Whereas:** *Phi Beta Lambda (PBL)*, the college division of *Future Business Leaders of America (FBLA)*, is a national organization focused on preparing students for careers in business through leadership, professional development, and academic competitions;
- Whereas:** The Cerritos College PBL/FBLA chapter helps students grow their skills in business, marketing, finance, and entrepreneurship through hands-on experiences, workshops, and competitive events;
- Whereas:** Cerritos College student Zaira Mora earned first place in a recent state competition, qualifying to attend the 2025 FBLA National Business Leadership Conference (NBLC), taking place in Dallas, Texas from May 31 to June 2, 2025;
- Whereas:** The conference offers students the chance to compete at the national level, take part in career development workshops, gain internship and job opportunities, and connect with other student leaders and professionals from across the country;
- Whereas:** This opportunity allows Cerritos College to be represented on a national stage, showcasing the excellence and competitiveness of our students and programs;
- Whereas:** Funding support would help cover key expenses such as registration, travel, and lodging for the student and one faculty advisor, making this opportunity more accessible and affordable;
- Resolved:** The ASCC Senate approves SB-2425-14 and authorizes a maximum of **\$2,420.00** to be expensed from the Senate Fund (600-03-015) to support the Cerritos College PBL/FBLA club's participation in the 2025 FBLA National Business Leadership Conference.
