## **COSMETOLOGY PROGRAM INFORMATION & RESOURCES**

#### **Program Overview**

This program will prepare you for a career in cosmetology by providing you the skills in hairstyling, haircutting, chemical services, nail care and skin care.

The Board of Barbering and Cosmetology requires a minimum of 1000-clocked hours, technicals and operations.

#### **Program Pre-requisites**

Completion of ENGL 100 or ENGL 100S or equivalent with a grade of "C" or higher or "Pass".

#### Program Pathway (flyer)

This program takes two 18-week semesters to complete. Students can begin this program once a year during the fall term. First session (1<sup>st</sup> 9-weeks, typical), Second session (2<sup>nd</sup> 9-weeks, typical), Third session (3<sup>rd</sup> 9 weeks, typical), and Fourth session (4<sup>th</sup> 9-weeks, typical).
