### G. DISCUSSION ITEMS

• Multiple Measures & AB705 changes – Lynn Serwin and Ken Matsuura Ken Matsuura provided handouts on AB705 from the Chancellor's Office to the committee (handouts will be available online at cerritos.edu/curriculum). From December 2017 "AB 705 requires community college districts to maximize the probability that students will enter and complete transfer-level coursework in math and English within a one-year timeframe by utilizing assessment measure that include high school performance to achieve his goal." The Multiple Measures committee will be in charge of looking into implementing this new policy. The college is now required to use high school transcript and GPA to maximize the possibility of students completing English and Math courses in one year. Counselors are able to look at high school data through a Cal-Pass system. The college is expected to be fully compliant to AB705 by Fall 2019. Matsuura recommends that curriculum should move the approval of all locally developed curriculum in Math and English to Fall 2018 to meet the AB705 deadline.

During the course of this discussion regarding AB705 the following concerns were raised in regards to its impact:

- Students that self-declare will have trouble adding a class if they are trying to enter a class that has prerequisite in PeopleSoft
- Some CSU may still require prerequisite as part of their transfer
- The assessment test may no longer be an option
- Blue slips are to be submitted to Admissions to have record that the student has self-declare themselves to a certain class (example ENGL 100)
- Some departments are not fully aware of the prerequisite changes and has not brought changes to curriculum. The Curriculum Chair Person and Curriculum Specialist will visit the All Chairs meeting in February to provide information related to prerequisite changes.
- Removal of requisite in PeopleSoft may impact transferability
- Students will not except recommendation from counselor and take a course they are not ready for

Lynn Serwin also shared her conversation with Stephanie Murguia regarding ENGL 100s prerequisite. ENGL 100s is a new combination course of ENGL 100 and 5L. The goal of offering ENGL 100s will eventually eliminate ENGL 5L option.

### • Courses with GE approval vs Standalone courses – Carrie Edwards

Carrie Edwards explains that the Chancellor's Office did not allow standalone courses for a few years, but is now allowing standalone courses again. Standalone courses are non-degree applicable courses. The courses will need to "meet a specific need to be offered". Edwards learned recently at the Regional Curriculum Workshop, that courses with general education could be offered before the program has been approved, since general education is considered part of a degree. She would like the college to consider this new practice.
