

**FIFTH AMENDMENT TO CONTRACT FOR EMPLOYMENT OF
VICE PRESIDENT OF BUSINESS SERVICES/ASSISTANT SUPERINTENDENT BY
CERRITOS COMMUNITY COLLEGE DISTRICT**

The Fifth Amendment is entered into this 10th day of December 2025, by and between the Cerritos College District and Mr. Felipe Lopez.

WHEREAS, the parties desire to enter into this Amendment to the contract.

NOW, THEREFORE, the parties hereto mutually agree as follows:

1. The term of Mr. Lopez's Employment Contract as Vice President of Business Services/Assistant Superintendent shall be extended from January 2, 2026, to January 2, 2029.
2. Except as expressly amended, all other provisions of Mr. Lopez's Employment Contract dated January 2, 2017, shall continue to remain in full force and effect.
3. Mr. Lopez shall continue to hold the title of Executive Vice President of Business Services/Assistant Superintendent in accordance with Board Policy 2432. In addition, Mr. Lopez retains his 3% stipend for serving in this capacity.
