This CSULA major has “major-specific admission requirements” which are focused on transfer student preparation that predicts success in the major and promotes timely degree completion. The criteria above reflect the current criteria as well as changes that will be used for the Fall 2024 admission cycle. The criteria listed will be reviewed annually for future admission cycles. For Fall 2024 term admission, coursework must be completed no later than the Spring 2025 term. For Spring 2025 term admission, coursework must be completed no later than the Summer 2024 term. Transfer students must meet minimum CSU Upper-Division Transfer Eligibility Requirements to be considered. Admission determination is then based on the major-specific criteria.

Students select a minimum of one of six emphases from the following: Accounting, Finance, Information Systems, Marketing, Operations and Decision Technologies, Organization and Management.

Minimum cumulative GPA of 2.7 in all transferable coursework and a minimum of 2.5 GPA in the 7 lower division preparation courses is required for consideration into the major.
